A motion by Clerk Wirwicki supported by Treasurer Eickholt to approve having the accountant do the yearly F65 report and audit. A roll call was taken. All Ayes. Motion Carried.

Trustee Buginsky discovered the IT company used to update our website posted minutes from another township onto our website and did not post our minutes. Clerk Wirwicki asked why she wasn't notified of this after discovering the whole board knew. No action was taken.
