Shiawassee County Road Commission (SCRC) Managing Director Brent Friess provided the 2018 New Haven Township proposed road projects. It was noted funding will no longer be provided by SCRC to apply brine to gravel roads. It was also noted the SCRC contribution for projects will be reduced from \$25,000 to \$10,000. Several projects were outlined including the completion of the Easton Road project. The Juddville Road project to be paid for by monies collected from gas tax. Prices will be firmed up by March.

## January 2018

The Board discussed the price increase for brine application. Supervisor Hill will discuss options with SCRC including the possibility of two 2,000 gallon applications, down from two 3,000 gallon applications in previous years.
